1. Project Background

- 1.1 the Development comprises a total GFA of about 24,000m², with two numbers of 29-storey residential towers over a 4-storey podium and 1-storey basement carpark.
- 1.2 the tender of the Sub-contract Works is scheduled to be issued in Q2 2018.
- 1.3 the Main Contract Works commenced in Q2 2017.

2. Scope of the Works

- 2.1 supplying and laying topsoil mix, soil conditioners, mulch and fertilizer to planting areas;
- 2.2 supplying and planting of ground cover plants, climbers, shrubs, trees; and
- 2.3 supplying and fixing sub-soil drain pipes inside planters.

3. Shortlisting Requirements

- 3.1 contractors who are or were the soft landscape contractors on at least one residential project which is currently progressing or has been completed in the past five years of comparable scale to the Project in Hong Kong; and
- 3.2 contractors who are not currently suspended from tendering under any relevant government list and have no unsatisfactory performance on current or completed URA projects in the past five years, if any.
