Please complete Part B to Part D of this Expression of Interest Form (EOI) with necessary documents and return it in a sealed envelope marked “Expression of Interest on Provision of Street Beautification Works at the Adjoining Streets of the GIC facilities at the Ground Floor of The Center ” to the Authority at 26/F, COSCO Tower, 183 Queen’s Road Central, Hong Kong (Attn: Mr Adam Chung, Manager, Planning and Design) by 2:00 p.m. on 17 August 2017 to express your interest in submitting a tender regarding the provision of Street Beautification Works at the Adjoining Streets of the GIC facilities at the Ground Floor of The Center (the “Works”).

Part A. Project Background and Brief

The Urban Renewal Authority is planning to issue a tender to carry out street beautification works to beautify the streets at Tit Hong Lane, Hing Lung Street, Tung Man Street, Wing On Street, Gilman Street and a portion of Gilman’s Bazaar. The scope of Works generally comprises but not limited to the following:

- Prepare detailed design and working drawings of street beautification works in accordance with the design intent, tender drawings and specification and make all necessary submission(s) to the satisfaction of the Authority and relevant government department(s) for approval;
- Liaise with the government department(s), utility companies, nearby shops, hawkers, building owners and management parties etc. to facilitate construction works;
- Re-pave the existing floor finishes/ utility covers with recycle pavers/ concrete pavers/ granite tiles in accordance with the detailed design drawings approved by the Authority;
- Re-finish existing staircase at Gilman Street in accordance with the detailed design drawings approved by the Authority;
- Replace/ repaint existing manhole covers, surface channels, gullies etc. and reinstate any of existing street features/ fixtures;
- Design, supply and install historic panels to each of the streets, with one set of spare panels handed over to the Home Affairs Department for maintenance;
- Coordinate with the Food and Environmental Hygiene Department, the hawkers and other contractors on financial and administration of enhancement work of existing hawker stalls; and
- Handover of the completed works to the satisfaction of the Authority and the relevant government departments/ management party.

The Contract is tentatively scheduled to commence in Q4 2017.
