## **Project Brief and Shortlisting Requirements**

## 1. Project Background

- 1.1. The public open space ("POS") within the completed redevelopment project at Kweilin Street and Yee Kuk Street, Sham Shui Po, Kowloon is approximately 6,300 sq.ft. in area; and
- 1.2. The POS was completed in the third quarter of 2015.

## 2. Brief Scope of the Services

The service provider for the Services shall provide all necessary property management services as described below for the POS for 24 months:

#### 2.1. Staff

- Provision of sufficient manpower of security staff for 24 hours (12 hours per shift) daily.
- The security staff shall patrol, handling special incidents and emergency cases whenever necessary.
- Provision of sufficient manpower of building supervisor for handling emergencies/complaints, supervising security team and maintain the condition of POS.
- Inspections shall be conducted by the building supervisor and report if any abnormal founding

## 2.2. Cleansing and Pest Control

- Provision of sufficient manpower of cleansing workers daily. The cleansing frequency will be increased during rainy days or whenever necessary.
- The routine cleansing work will be including sweep, clear up rubbish, garbage, leaves, etc. within the POS area.
- Provision of mobile team for carrying out thorough cleansing work including use of high pressure cleansing machine to clear up dust and dirt at floor and wall etc.
- To provide general pest control and rodent control specialist service.

## 2.3. Repair & Maintenance

- Carrying out regular inspections.
- Provision of sufficient manpower of technician for carrying out minor repairs and maintenance of Electrical Installation, Plumbing and Drainage, Carpenter, Blacksmith, Plaster, Painter, Upkeep and patch repair / replacement the wooden decking, CCTV maintenance, Water fountain, and Miscellaneous works.

# 2.4. Gardening & Plants

- Provision of manpower for routine watering and pruning on plant and trimming.
- The service provider shall replace the seasonal flowers / plants.
- Provision for plant signage would be arranged according to current plant mix.
- Annual tree inspection by certified arborists will be carried out by the service provider

## 2.5. Sundry

• To purchase stationeries, signage, fencing tapes and warning tapes, etc.

#### 2.6. Festival Decoration

• Installation of pin lights and/or decorations for Mid-Autumn Festival, Christmas and Chinese New Year.

# 2.7. Insurance

• Effect the third party liability insurance and property all risk insurance for the POS during the contract period.

## 3. Shortlisting Requirements

- 3.1. The interested party shall have at least 1 on-going job of property management in the past five years including the provision of management services for a scale of open space (both public open space and private open space) within a property with not less than 3,000 sq.ft. GFA.
- 3.2. The interested party shall declare that it is not currently suspended or restricted from tendering (including voluntary suspension and restriction) under any of relevant government lists and lists of Hong Kong Housing Authority (HKHA) and Hong Kong Housing Society (HKHS).
