# 1. Project Information and Scope of Works

Site Location\* Chun Tin Street/Sung Chi Street/ Hok Yuen Street

Project area about 2,353 m<sup>2</sup>

The general scope of works includes the following:

# Foundation Works

- (1) Removal of existing sub-structure and foundation including provision of all necessary temporary works for removal of existing sub-structures and foundation;
- (2) Installation of bored-piles and pre-bored socketed steel H-pile;
- (3) Installation of pipe pile and curtain grouting;
- (4) Carrying out pumping test(s) prior to basement excavation;
- (5) Installation of excavation lateral support works and carrying out basement excavation;
- (6) Installation of monitoring system and carrying out monitoring works including reporting;
- (7) Installation of pile caps and basement structural slabs;
- (8) Carrying out all tests and submissions of test reports and records in accordance with the Building Ordinance;
- (9) Carrying out all necessary works to prevent undue settlement of adjacent ground, utilities and adjoining properties;

#### Road Improvement and Utilities Diversion Works

- (10) Road widening of Sung Chi Street;
- (11) Construction of new vehicular turning area, footpath, layby, run-in/out;
- (12) Associated road resurfacing, road markings, traffic signs, traffic aids, street lighting, road gullies and drainage works;
- (13) Removal of abandoned utilities / services, carrying out utilities diversion works and works to facilitate some of the utilities diversion which shall be carried out by the utility undertakers and the Government departments;
- (14) Formation of new footpath along Hok Yuen Street;
- (15) Sewerage improvement works at Hok Yuen Street;
- (16) Application of excavation permits and all associated government submissions.

#### 2. Shortlisting criteria

The contractor shall fulfill the following shortlisting criteria:

- a) The contractor is on the Development Bureau's list for Approved Suppliers of Materials and Specialist Contractors for Public Works in the category of Land Piling (Group II Contracts / Sub-contracts of unlimited value) with specialty in Large Diameter Bored Pile (with bell-out) & Rock-socketed Steel H-pile in Pre-bored Hole
- b) The contractor has completed at least one foundation contract with the contract sum above HK\$68 million in the past five years in Hong Kong before the closing date of the pre-qualification.
- c) The latest performance record of the contractor for URA's in house projects in the past five years before the closing date of the pre-qualification, if any, shall not be marginal or below.
- d) The contractor is a registered specialist contractor (sub-register of foundation works category) in the Buildings Department's register.
- e) The contractor is not currently suspended or restricted from tendering under any relevant list of the Government, Hong Kong Housing Authority and / or Hong Kong Housing Society.
