## **Project Brief**

#### 1. Project Background

- 1.1 The Carpenter Road Park located at Carpenter Road, Junction Road and Tung Tau Tsuen Road, Kowloon City, Kowloon. Public open spaces with approximate 34,000 m<sup>2</sup> site area (refer to Appendix A for the location plan).
- 1.2 The Project will be and the Services are tentatively scheduled to commence in 2nd Quarter 2023 and complete in 2nd Quarter 2026.

## 2. Scope of the Services

The scope of the Services for the Project generally includes the following:

- 2.1 provision of professional architectural services and the services of an authorized person ("AP") registered under the Buildings Ordinance to provide architectural services, including contract administration, detailed design preparation(provisional), site monitoring and supervision, etc. for completion of the project. The AP also act as lead consultant to coordinate with different consultants/ sub-consultants, contractors/ sub-contractors, utility companies and the separate independent checking consultant ("ICC") and SDC employed by URA;
- 2.2 provision of the service of a registered structural engineer ("RSE") and registered geotechnical engineer ("RGE") registered under the Buildings Ordinance for structural engineering services and geotechnical engineering services including the detailed design and calculations(provisional), site supervisions, etc. for the Project (see note below);
- 2.3 provision of building services engineering ("BSE") services including detailed design(provisional) and site supervision for the mechanical ventilation, air-conditioning, fire services, plumbing and drainage services and electrical services etc. of the Project (see note below):
- 2.4 provision of landscape architectural ("LA") services including detailed design(provisional), administration of Phase 1A advance tree works contract, site monitoring, supervision of soft and hard landscaping, playground equipment including Certified Playground Safety Inspector (CPSI) service, make amendment as necessary to the Tree Protection and Removal Proposal (TPRP) and obtain LCSD's approval, etc. up to the successful handover of the site to LCSD including any required establishment period (see note below):
- 2.5 provision of resident site staff including (registered engineer, building services inspector, clerk of works and field officer) as and when necessary, upon confirmation by URA for the on-site supervision and coordination with the contractors (see note below);
- 2.6 provision of quantity surveying ("QS") services for the post contract work for the main contract works. In addition, provisional services of preparation of tender document, provision of cost estimation, tender assessment, contract award and shall be included;
- 2.7 examination of the contractor's working design and method statements concerning the design and construction of the Revitalization Works of CRP; and
- 2.8 provision of an independent checking consultant team("ICC")(provisional) (separate team of AP, RSE, RGE and BSE) (see note below);
  - (i) To ensure the designs in compliance with all statutory requirements, employer's requirement, terms and conditions of the Contract; and
  - (ii) To certify the designs that had fulfilled required standard.

Note: The services relating to structural and geotechnical engineering, building services engineering, landscape architectural services, quantity surveying services and resident site staff can be provided in-house or by sub-consultants appointed by the successful consultant.

## 3. Shortlisting criteria

- 3.1 The consultant is either 1) on the URA List 1 of Architectural Consultants (see notes 3) or 2) on the List of Consultants of the Architectural and Associated Consultants Selection Board Consultants ("AACSB") maintained by the Architectural Services Department (architectural category Band 1, i.e. estimated project value exceeding HK\$400 million each ) and (architectural category Band 2, i.e. estimated project value not exceeding HK\$400 million each)
- 3.2 the consultant shall have experience in providing architectural consultancy services for at least one open space or park destined for public use, completed in the past ten (10) years before the closing of the pre-qualification and having a site area of public open space / park not less than 17,000 m2);
- 3.3 the consultant shall have experience as a lead consultant in providing consultancy services including sub-consultants/in-house services for structural engineering, building services engineering and Landscape consultancy services engaged for at least one project with the contract value of the construction works not less than HK\$320 million currently in progress or completed in the past five (5) years before the closing of the pre-qualification;
- 3.4 the consultant is not currently suspended or restricted from tendering under any relevant list of the Government, Hong Kong Housing Authority and/or Hong Kong Housing Society; and
- 3.5 the consultant's latest performance record in URA's self-developed projects in the past five years before the closing of the prequalification, if any, shall not be marginal or below.

#### Remarks:-

- i. The above-mentioned two experience criteria in 3.1 and 3.2 above can be fulfilled by one project or different projects.
- ii. If the consultant is a company, only one company from a consultant and its associated companies (as defined in Section 2(1) of the Companies Ordinance (Cap.622)) will be shortlisted. In the event of PQ submissions received from a consultant and its associated companies, the Authority will follow up with them to seek the confirmation of which one of them to apply for pre-qualification for the above services. If the consultants fail to respond or otherwise fail to decide which company to be chosen for the application of PQ, the consultant whose company name ranks first in alphabetical order and comply the above-mentioned shortlisting criteria will be shortlisted.
