1. Project Background

1.1 The Development Scheme Plan of Project KC-015, located in Kowloon City, was approved on 29 September 2020. The site covers a total land area of about 5,307m², bounded by Kai Tak Road, Prince Edward Road East, Sa Po Road, and Carpenter Road.

KC-015 will provide approximately 810 small-to-medium sized residential units with a maximum total Gross Floor Area (GFA) of about 47,763m². The development also includes a podium for non-domestic uses, including retail spaces.

The excavation and lateral support plan and foundation plan were submitted to buildlings department in March 2025. Accordingly to the current project timeline, the Works are scheduled to commence in Q4 2025. Hence, it is considered approraite time to pcorue the works contractor for carrying out the Works.

2. Scope of Works

The scope of the Works generally includes the following:

- 2.1 Installation of bored-piles and socketed steel H-piles;
- 2.2 Installation of pipe piles and grout curtain;
- 2.3 Installation of excavation and lateral support works and carring out basement excavation;
- 2.4 Installation of monitoring system and carrying out monitoring works including reporting;
- 2.5 Installation of pile caps and basement structural slabs;
- 2.6 Carrying out all tests and submissions of test reports and records in accordance with the Building Ordinance;
- 2.7 Carrying out all necessary works to prevent undue settlement of adjacent ground, utilities and adjoining properties; and
- 2.8 Diversion of all necessary utilities, including the application for excavation permits, temporary traffic arrangements, and reinstatement works etc.

3. Shortlisting Criteria

- 3.1 The contractor shall be a registered foundation contractor under the Buildings Department's Register of Specialist Contractors (Sub-register of Foundation Works Category) as at the closing date of pre-qualification with proof by producing the certificate (see Note (1) below) or letter issued by the Buildings Department to show the expiry date of registration later than the closing date of the pre-qualification exercise;
- 3.2 The contractor shall provide at least one job reference of completed or on-going foundation contract adopting large diameter bored pile in Hong Kong in the capacity of the registered specialist foundation contractor under the Buildings Ordinance with the contract value of not less than HK\$200 million in the past ten (10) years before the closing date of the pre-qualification exercise;
- 3.3 The contractor shall provide at least one job reference of completed or on-going excavation and lateral support works with not less than 2 storeys of basement excavation in Hong Kong in the past ten (10) years before the closing date of the pre-qualification exercise;
- 3.4 The contractor shall have at least one authorized signatory registered with the Buildings Department in respect of its foundation contractor registration;
- 3.5 The contractor shall not have any serious site accident within the 6-month period ending on the closing date of the pre-qualification exercise; and
- 3.6 The contractor's latest performance on URA's self-developed projects shall not be unsatisfactory before the closing date of the pre-qualification exercise.

Note:-

- 1. If the registration has expired, the contractor shall submit supporting documents to prove that the application for retention/ renewal of the registration has been made. As mentioned on the website of the Buildings Department, if an authorized person/ structural engineer/ geotechnical engineer/ inspector/ contractor has made an application for retention/ renewal within the statutory time limit, his registration will continue to be in force until such application for retention/ renewal is finalized by the Building Authority even if the expiry date shown on the certificate of registration has elapsed.
- The contractor can either submit separate project references for each criterion or submit a single project reference that fulfills both the criteria of 3.2 and 3.3.
