Project Brief

Construction of 11-a-side Soccer Pitch at Shing Fung Road, Kai Tak for Project YTM-013 – Proposed Development at Sai Yee Street / Flower Market Road

1. Project Background

- 1.1 The construction of 11-a-side soccer pitch at Shing Fung Road, Kai Tak ("Works"), aims to relocate the existing Boundary Street Recreation Ground at 200 Sai Yee Street, Mong Kok, Kowloon to the site located at Shing Fung Road, Kai Tak with the site area approximately 14,500 m2.

The reprovisions shall be on interim basis to construct an 11-a-side soccer pitch and its ancillary facilities (e.g. changing rooms and toilets, management offices, soft landscape works, hard landscape works, etc.) and then handover to the LCSD for their operations.

The contract for the Works is tentatively targeted to be awarded in 1st quarter of 2026 and the Works are targeted to be completed in Q1 2027 and handed over to LCSD in Q2 2027.

2. Scope of Works

The scope of the Works generally includes the following:

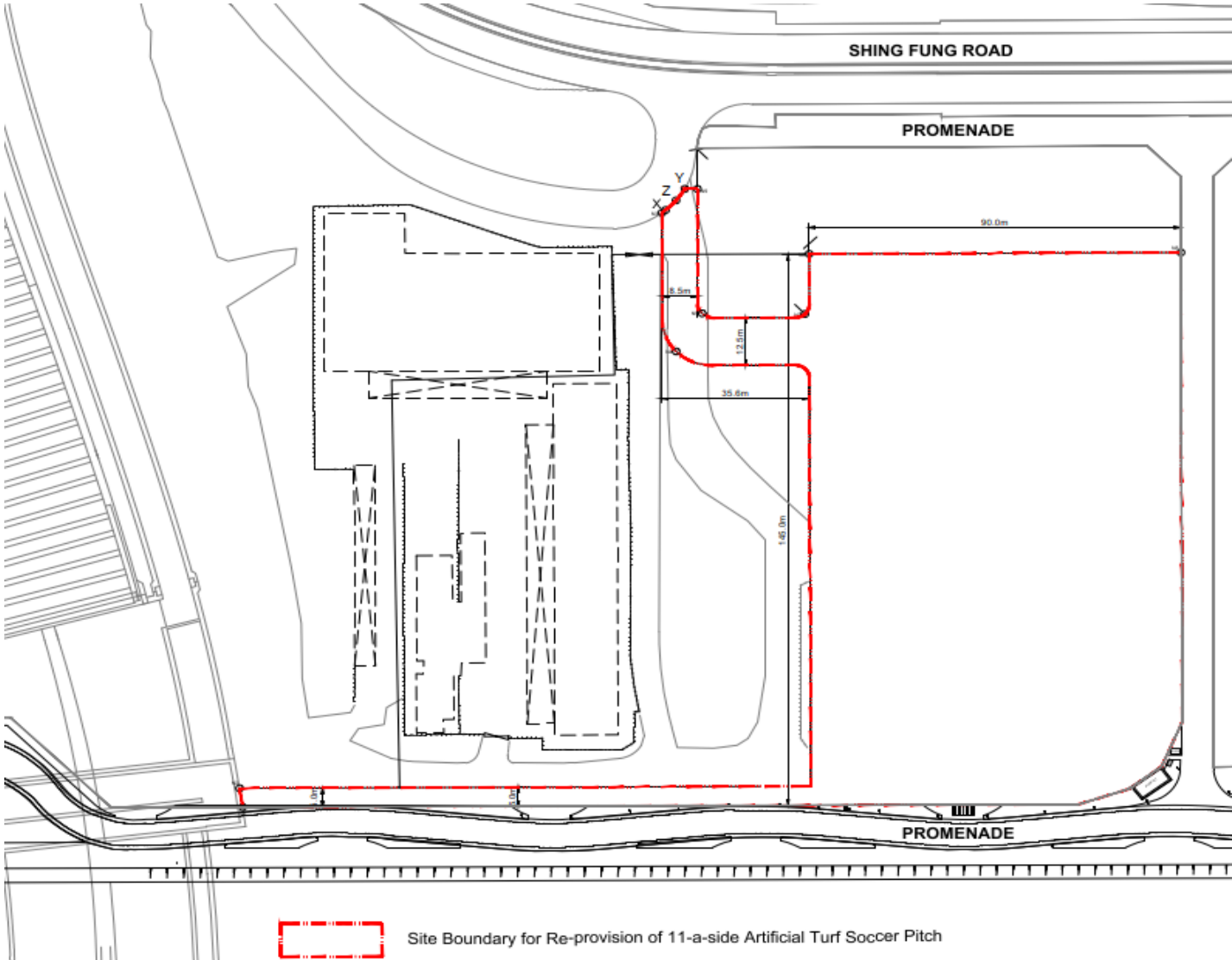
Construction of an Interim 11-a-side Soccer Pitch

- 2.1 Construction of an 11-a-side soccer pitch, perimeter fence, spectator stands;
- 2.2 Construction of ancillary facilities (including female/male toilets with changing rooms, accessible toilet, universal toilet and shower facilities, baby care room, first aid room, management office, staff room and general storeroom etc.) and relevant supporting plantrooms;
- 2.3 Provision of zero carbon design for solar hot water system and photovoltaic panels;
- 2.4 External landscape works;
- 2.5 Underground utility lead-in works;
- 2.6 Construction of hoarding, gantries and associated works (e.g. hoarding graphics) according to the approved hoarding plan;
- 2.7 Coordination with relevant government departments and utility companies;
- 2.8 Preparation of as-built records, operation and maintenance manuals; and
- 2.9 Testing, commissioning and handover of the Works.

3. Shortlisting Criteria

- 3.1 The Contractor is currently on the Development Bureau's List of Approved Contractors for Public Works in **Group A** (probationary or confirmed status) or **Group B** (probationary or confirmed status), in the **Buildings** Category;
- 3.2 The Contractor shall possess at least **one job** reference of **completed** or **in progress** construction works within the **5-year period ending on the closing date** of the pre-qualification exercise in Hong Kong in the capacity of the **main contractor** and having **Leisure and Cultural Services Department ("LCSD")** as the user or **one of the users for (1) open space or (2) sports centre or (3) any other sports related facilities** that were/will be subsequently handed over to LCSD.
- 3.3 The Contractor's performance on URA's self-developed projects (if any) during the specified period shall **not be unsatisfactory** as evaluated by URA. This specified period means the **six months preceding the closing date** of the pre-qualification exercise;
- 3.4 The Contractor **must not** have experienced any **fatal site accident** on any of its works sites within the **specified period**. This period means the **six months preceding the closing date** of the pre-qualification exercise.
- 3.5 The Contractor shall not be under **suspension or restriction from tendering** (including voluntary suspension and / or restriction) under any relevant list of the Government, the Hong Kong Housing Authority and / or the Hong Kong Housing Society **as at the date of closing date of the pre-qualification exercise**.
- 3.6 The Contractor (including its **directors** and **management staff**) has not been:
