

市區重建局重建項目 測量師費用津貼簡章

1. 如有意的話，重建項目內的物業業主可聘用具備專業資格的測量師向他／她提供下列服務（「該等服務」）：
 - (a) 評估其物業的市場價值（但不包括任何特惠津貼，如自置居所津貼及補助津貼等）及向市建局遞交有關估價報告（「該估價報告」）；及
 - (b) 就市建局提出的收購建議中的物業市場價值，與市建局進行商討。
2. 在合乎本段 2 下列(a)至(e)分項所述的所有條件下，業主可就聘用一位專業資格測量師提供該等服務一事，向市建局申請津貼資助有關該等服務所需測量師費用（「該津貼」）：
 - (a) 業主須先自行支付有關提供該等服務的測量師費用，然後向市建局提交有關付款憑據以申請該津貼。

 - (c) 該估價報告須包含**附件 B** 估價報告樣本內所需資料。
 - (d) 該估價報告須於首次收購建議期限屆滿的二十八日前向市建局遞交。
 - (e) 市建局已成功購入業主的物業及完成有關買賣合約。
3. 在收妥業主的申請及其支付測量師費用之付款憑據後，市建局將有最終酌情權考慮向業主發放該津貼的最終金額，惟市建局所發放的該津貼的最終金額將不會超過下列按物業類別所指定的最高津貼額：
